1. For everyone not continuing on to the USA State Meets or Extended Practice, tomorrow's practice will be the last of this season. Fall/Winter practices will begin October 11. We will again offer Preseason Stroke & Training Sessions, Silver Sharks and Competitive Stroke classes beginning after Labor Day. Please check the Y program guide for times and days. You may register for both Silver Sharks and Competitive Stroke classes at any Y, by phone, or on line. There will also be a continuation of practices on both Tuesdays and Fridays after Labor Day. These practices will be for Gold 1 only. I will be having our annual Fall All-Parents meeting on Tuesday, September 28<sup>th</sup>, 6:30-8:30pm, at the DT Y. Please get this meeting on your calendars right away. I will also send a mailing out to all families in August. This mailing will also be mailed to this summer's Silver Sharks.

2. Many swimmers have asked for practices to continue through August until Labor Day. Beginning this Friday, July 23, we will have one practice daily which will include all GBY swimmers wishing to continue training through the off-season. The fees for these extended practices are \$75.00 for the first family member, and \$50.00 each for additional family members. These program fees will be charged to your escrow account. The Y expects all families to deposit enough money into their escrow accounts to cover these fees, by July 31, in addition to paying any current outstanding escrow balances. For most of these extra practices, I do not have the entire pool. The number of swimmers per lane will depend on how many attend each day. But lanes will need to be left available for Y members. There will be no attendance taken except the list of who is attending these practices so they can be charged for the program. The schedule is below. These practices will also include our team members who are still competing at meets this summer. I will coach many of these workouts, but a number of these practices run by assistant coaches:

3. Seven GBY swimmers are participating in the 12&under USA State Meet at the Schroeder Aquatic Center, this Friday-Sunday, July 23-25. I just forwarded an e-mail with the psych sheet, time line and warm-up assignments. Please look over the e-mail carefully. WARM-UPS Friday - 3:00pm, Saturday AM 8:30am, Saturday PM 1:45pm, Sunday AM 8:55am, Sunday PM 2:00pm. Please be ready to warm-up before our assigned time begins. I will be at the meet all weekend. Refer to Wisconsin Swimming's website for all information for the meet. Directions to Schroeder – Take I-43 south. Exit on Brown Deer Rd west. Take Brown Deer Rd to Green Bay Rd and go north. Entrance to the Y and aquatic center will be on the right about ¼ mile up.
4. Nine GBY swimmers are participating in the 13&over USA State Meet at the RecPlex, in Pleasant Prairie, near Kenosha. The address of the pool is 9900 Terwall Terrace, Pleasant Prairie, WI 53158. I have never been there, so I do not know directions. But it is near I-94 and Illinois. Please refer to Wisconsin Swimming's web-site for all the information regarding this meet. Warm-ups are each morning from 7:30-8:50am, but will be assigned. We should see the assigned lanes sometime next week. I also expect to see the psych sheet and time line sometime next week. Please plan ahead and get directions to the pool. And please be on time for all warm-up sessions. I will be at this entire meet.
5. I am attaching a registration flyer for Swimmers' Camp at Camp U-Nah-Li-Ya. I ask that you be registered by August 5. There will be a bus leaving the Westside Y at 9:30am on Monday, August 23, and returning there at 2:00pm on Wednesday, August 25. As of now only about a dozen kids have registered and only female chaperones. The camp needs to have enough chaperones to run this camp, and we need a couple male chaperones. I know I had some male volunteers but have not seen your children's registration forms yet.
6. I will send a mailing out in August with much more about the Fall/Winter season. Please refer to the Y Program Guide for class information. Our times will not change at all from the 2009-2010 season. There will be a couple minor changes, but those are for the upper level swimmers.
7. I have only had a couple inquiries regarding the Parent Group Committee. We are in need of 3-4 parents to fill spots for the 2010-11 season. Meetings are held the second Monday of the month from 5:30-7:00pm, at the DT Y. Each parent group member will also oversee a parent sub-committee group. At our September 13 meeting, I would like to have a full committee in place to begin the season. Please, if anyone is interested, contact me for more information.
